

Will EPA add solar panels to Universal Waste Regulations?

On October 23, 2023, EPA announced a new rulemaking effort to improve the recycling and management of end-of-life solar panels and lithium batteries. EPA is developing a proposed rule to add solar panels to the universal waste regulations and to add tailored universal waste standards for lithium batteries.

Do I need a NPDES permit for a solar panel farm?

If the earth disturbance associated with the construction of a solar panel farm, over the life of the project, will be 1 acre or greater, NPDES permit coverage is required pursuant to 25 Pa. What earth disturbance activities are required to construct solar panel farms?

Earth disturbance activities necessary to construct solar panel farms will vary depending on the topography, slopes, soils of the proposed location of the solar panel farm, the layout of the solar arrays, and whether the arrays are fixed-tilt or solar tracking. Each project is different and needs to be evaluated independently.

Are solar panels regulated at end of life?

Can a licensed professional assess a solar panel support structure?

To qualify under 25 Pa. Code § 102.8(n), a licensed professional must conduct an assessment of the proposed solar panel support structures/foundations with regards to increases in earth disturbance and impervious cover as compared to the existing condition.

What BMPs should a solar panel farm use?

A proposed solar panel farm must utilize E&S BMPs that are applicable to the size and scope of the project, which can be found in DEP's Erosion and Sediment Pollution Control Program Manual (E&S Manual) or on DEP's website (Alternative E&S and PCSM BMPs).




